

## Crunching Numbers in Region Six

The Editor's Perspective —Marsha Hayes

It's October.... Three rides this month in Region Six and I want to do all of them. Time to crunch some numbers. How many days can I be gone from home? Might need 12 at the most, 9 if I can get a night driver. Numbers tight. If my husband and I both go, I must look into his leave situation at work and his complex work schedule. This analysis involves something called PTO hours, annual leave hours and banked time and potential overtime lost analysis.

Then comes figuring the ever changing price of diesel fuel and figuring the miles driven, divided by the miles per gallon. From my location it looks like 150 gallons of fuel should do it. This could run about \$420 to \$500. Six entry fees should run about \$400 and then there will be camping fees and additional road food. We will throw in another \$75 per ride for another \$150. Realistically, attending the last three rides could easily cost \$1,050 in cash outlay in one month. Realistically, this will be very, very hard.

The number crunch that arrived at a figure slightly over \$1,000 does not include lost overtime, put any value on vacation days or factor in the exorbitant cost I am now spending to properly shoe two horses and the many gallons of fuel spent driving to conditioning rides with a first time rider I am training with.

What is the proverbial bottom line? Can I afford to do three rides in one month? Can I afford not to? I can honestly say I have never had a bad time at a ride. Some of the best memories of my life center on rides and the people I have ridden with and the time with my horse. There is also the temporal quality of my soundness and the ever present concern that the horses will stay healthy and sound. Life and NATRC offer no guarantees.

Conserving one's money is much like riding smart on a long ride. Do we splurge on every ride that comes along because "I might not be riding in the fall" or do we save our money for the stunningly beautiful October weather and finish strong? It all depends on knowing your horse and how strong a financial steed we are individually mounted on.

If you DON'T see me at all the rides in October, you can surmise any of several options: lame horse, sick horse (ditto for rider), or team pulled for being called slightly off on the right front checkbook. If you **do** see me at all the October rides you can surmise any of several options: horse sound, rider healthy, classes are being skipped and financial analysis determined electricity highly overrated as a necessity. Anyone got any spare candles?

## PRESIDENT'S MESSAGE

Where is the time flying to? It seems like only yesterday that we were at Big Hill and now we are looking at the last three rides of 2006!

In some ways this has been a difficult year in that with gas/fuel prices many riders were forced to cut back on the number of rides they were able to go to. Thankfully, in September prices began to drop and more folks are signing up for the last few rides.

Our ride managers have been very brave. In the face of potential dollar losses they have gone ahead and put on their rides. Please competitors don't forget that at most rides any losses come directly out of the ride manager's own pocket. I know some managers said they would go ahead this year but can not handle more than one year at their own expense.

Next year, one ride manager has made the decision to go ahead and sanction the ride and get started, BUT, if faced with another year of losses, the manager said they will make a decision about 2 to 3 weeks before the ride as to whether they will cancel. I understand that many folks were delaying getting ride entries in as they watched fuel prices. However, next year try to get your entry in at least a month in advance. Waiting until the last minute may cause a ride to be cancelled. We do not want rides cancelled!!

I am optimistic. Oil prices have gone down, no hurricanes to disrupt refining and hopefully no major world crisis to cause another major run-up. Let's cross our fingers!

## ***Voracious Cattle Disrupt Nebraska CTR***

Although far from Roswell, New Mexico strange actions of Nebraska cattle caused speculation about possible alien involvement with the disappearing trail markers in the Nebraska National Forest. The catered dinner was excellent, thanks to the 4-H camp cook. The judges, Vet Shannon Leska and Horsemanship Norma Newton made the ride fun. Even though it was cool, the sand helped separate the horses. It was lots of work for the horses.

"It was kind of a mystery all weekend, where the cattle would be," said Yvette. Anyone crossing Yvette's path should thank her promptly and sincerely for hosting this new ride. It was well done, enjoyed, and appreciated.

### Dave Smith Fall Fiesta Report

Well, Flash and I finally have 35 miles of official NATRC mileage in the books. And we had a great time to boot! The weather was lovely (aside from the torrential downpour Sat night, at least it wasn't tornadoes), the trails beautiful and exceptionally well-marked, the company excellent as always, and the food delicious and warming. Horsemanship judge Cheri Jeffcoat and vet judge Pat Rieger did a fabulous job and were incredibly friendly and helpful. Jerry and Cheryl Weber did a wonderful job organizing everything, and trailmaster Charlotte Henderson did an excellent job putting together the routes. This park seems to be difficult to route and time without getting bunched riders, but I was for the most part able to find nice pockets and only had to contend with a few Open riders (love you guys, but it sure drives my horse nuts to get passed up by you all the time!). We had a great P&R crew (including my fiancé and mom, thanks guys!), super camp cooks (ok, you all know how good food tastes when you

don't have to make it yourself), fabulous safety riders, and a ton more great volunteers who I'm probably forgetting. A HUGE thank you to all who helped organize and run this ride, you all did a FANTASTIC job.

The trip down went pretty smoothly, Flash loaded like a pro for a change and we were able to get on the road fairly early (with an 8 hour trip ahead of us). All went well until the back route into the campsite I thought I'd planned out nicely turned out to be a dead end at a bridge out, so we had to back the trailer several hundred feet to get turned around and detoured to a lovely rutted, muddy road (thank god for 4-wheel drive) followed by a rather exciting creek ford. I'm starting to think this is a forewarning. That adventure over, we made it safely into camp, checked in and had a superb chili dinner. Then as I'm standing around chit-chatting, I look over to see a horse grazing not 20 feet from the management tent. I had to look a little closer before I realized it was MY horse. He managed to Houdini himself right out of his halter and all. So I did the neck rope stallion-eske double tie for the night and that seemed to do the trick.

Flash, living up to his name, was quite a pistol Saturday morning and couldn't stand still at the start, so we ended up being very last out of the gate. Then he apparently convinced himself he was part Irish (all that red hair, who could blame him), and jigged his way on down the trail. I don't think we walked more than five steps in a row until at least 15 miles into the day. I started singing "walk, walk walk" in tune to his teeth grinding. Just did my best to keep my cool, breathe, and have a sense of humor about it all. Everyone else seemed to just want to get out of our way :-). I'm not sure if I said "thank you" or "sorry" more often throughout the day, and probably not often enough of either. Somewhere in the blur, there was a trot pole obstacle; backing; a mount from the ground; a dry creek bed crossing where we had to halt just before, back five steps, and then proceed across; a side-pass across two logs positioned in an L shape; and a couple of P&Rs and metabolic checks. Flash got left at a couple of obstacles and had an absolute fit, then Cheri had to remind me to wait for the next rider as I was so frustrated and flustered by that point, and Flash just wanting to go on down the trail that I darn near forgot myself! So, we didn't do terribly well on any of the obstacles, but he was pulsing down remarkably well at the P&Rs for how high he was coming in (no points lost!), and only lost a single point for hydration even though he wouldn't drink on the trail at all. Back at camp, Cheri had us "rescue" our horse from mortal danger by finding our knives and cutting a rope.

All the fighting Saturday left Flash with a little bit of a sore back and a tender girth area, but Sunday morning the back seemed fine, and though he still seemed ouchy to the touch in the girth, when I cinched up the saddle, his only complaint seemed to be that I wasn't going fast enough. I had half considered pulling him, but I'm really glad I gave him the chance because he would have been \*really\* mad to get left in camp. He was again a handful, and we timed out last once more. He started jiggy-jogging along again, only this time the trails were quite wet and slick from the overnight rains, and he was all over the place. I got very worried he was going to slip and really hurt himself. But then we bumped into Rhonda and Angela, who held my hand through a large portion of our very first ride last year, and their incredible mares worked their magic on Flash who finally decided to chill out. However, that monstrous walk of his proved to be too much for poor Rhonda's mare, we totally wrecked her P&R, and we had to split off. I went off ahead and found a nice pocket just behind the front-runners where he could walk his little heart out. At one point we got to be nearly 40 minutes ahead of our optimum time, even with the mud, and all at the WALK. Holy cow can this horse move! Obstacles for the day were a simple observation of a wooden bridge crossing, an observation of us walking up a hill to the P&R, then back down, and then just watching and a metabolic check at the second P&R. Flash did really well for me once he'd settled, and we had a great day. He still wouldn't drink on the trail, but by the second P&R he'd finally figured out how to drink from a water bottle, albeit sloppily, so I got a little water into him at least. Coming into the 2-mile marker, we'd passed up everyone else and were in the very front of the pack, so had to wait awhile to get back on time. He started to wig out a little again when the whole pack came over the hill to the marker, so we just hung out there with the safety riders until they'd all gone. At checkout he was feeling really good, and just couldn't wait for the trot-out. If I can get his brain in gear and get a little more control, he might just be ready for Open next year, though it feels a bit soon, with only 2.5 rides under our belt. He's definitely physically capable, what I worry about is that mental aspect.

Anyway, thanks to everyone who helped out, and let me pass on the trail :-). Hope we didn't mess anyone else up too badly, I know ya'll just wanted to get away from us all day and I don't blame you. We had a great time and went home with a ton of stuff to work on. Maybe someday we'll get good at this whole thing ;) Wish I'd had a

## **NATRC Clinic Held at Rainbow Meadows**

Labor Day weekend Karen Everhart held a sanctioned clinic at Rainbow Meadows, her ranch near Sedan, Kansas for the express purposes of introducing competitive trail to interested newcomers. Eleven riders took advantage of this opportunity and expressed unanimous approval for the clinic.

With an agenda that covered check-in, stabling, the NATRC mission and philosophy, the clinic quickly moved to conditioning, nutrition, tack, and riding rules. The afternoon was devoted to a five mile mock ride complete with ribbons, obstacles or observation, judges, and timers. The combination made for an extremely well received experience with participants still paying attention and asking questions past the long day's ending time of 5:30 PM.

## Centered Riding® Workshop for Trail Riders
