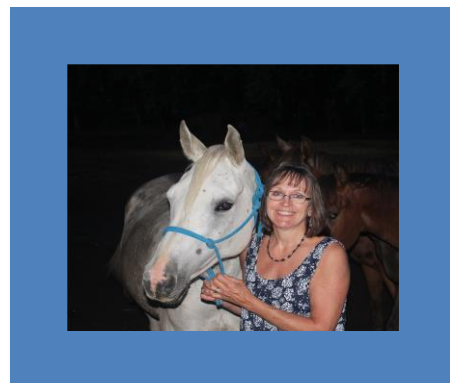

Kanopolis Canyons Competitive Trail Ride
April 13-14, 2019

Governed by the Rules of the North American Trail Ride Conference
Sanctioned by NATRC and MOTDRA

Type A (two day) Ride: Open, Novice, CP60 Rider Limit

Trails: Come out and enjoy well established trails and beautiful, unexpected scenery in the hills, canyons and prairie of north central Kansas.

Location: Kanopolis State Park, **200 Horsethief Rd, Marquette, KS 67464**, just west of Lindsborg.

Directions: From north & east: I-70 west of Salina to Brookville exit; south to Brookville. At intersection of Hwy 140, turn west and continue to Hwy 141; turn south to Kanopolis Lake. Turn west into the state park, just before the dam, and follow signs to Rockin' K campsite. From west: I-70 east to Ellsworth exit; south to Hwy 140; turn east to Hwy 141, then turn south to Kanopolis Lake and continue as above. From south: I-135 north to exit 72, Lindsborg. Turn west and go to the end of the blacktop. Turn north to Lindsborg, then west on Hwy 4 approx. 18 miles to Hwy 141. Turn north to Kanopolis Lake and cross over the dam. Turn into state park, just past the dam, and follow signs to Rockin' K campsite.

Camping: Showers, toilets, horse water, and limited electrical and water hook-ups are available. **Please make your own reservation for a campsite as soon as possible by contacting Kanopolis State Park at 785-546-2565 or www.reserveamerica.com** . You will need to pay a reservation fee in advance; you can pay camping and utility fees when you come to the ride. A few campsites have been reserved for workers and management; contact Ride Chair to see if you are on that list. You only need reservations for Friday and Saturday nights, not Sunday, unless you plan to stay until Monday. Please note late arrival on your entry form.

Stabling: All horses will be stationary tied to hitching posts.

Check-in: with ride secretary starting at noon on Friday; with judges starting at 2 pm on Friday. Proof of negative Coggins test is required on all horses in camp. Current health papers required on all out-of-state horses. **Dogs must be kept leashed and are not allowed at briefings or meals.**

Friday and Saturday night potluck: Bring your favorite covered dish to share and bring your own table service (plate, utensils, napkin, cup).

Entry Fees: Adult "A" Open, Novice, and CP \$90 member..... \$115 non-member
Junior "A" Open, Novice, and CP \$70 member..... \$ 95 non-member

Branching Out Competitive Trail Riding Clinic and NATRC Leisure Division Ride April 27 and 28, 2019

Area 2 of the Branched Oak State Recreation Area, 12000 W Branched Oak Rd, Raymond, NE 68428
Governed by the rules of the North American Trail Ride Conference (NATRC) **30 Rider Limit**

NATRC Clinic (Saturday April 27)

Leisure Division Ride (Sunday April 28)

The clinic will start with rider check-in with Ride Secretary on Saturday April 27 at 9am. There will be unmounted instruction in the morning followed by lunch (included with your entry fee). In the afternoon, you will learn how to check-in with your horse, and then experienced NATRC competitors will teach you how to successfully navigate obstacles and the equitation opportunities that may be encountered in an NATRC ride. Branched Oak has a new equine playground built by Nebraska Horse Trails Committee, which will provide some fun challenges.

The Leisure Division Ride will start with check-in of horses starting at 9am on Sunday. Time-out will start at 10:30 am. The distance will be approximately 10 miles, at a pace of approximately 3.5 mph. There will be one P&R (Pulse and Respiration check) and 2 to 3 judging observations. Terrain is barefoot friendly. This division is NATRC sanctioned and NATRC members will earn points towards regional year-end awards and mileage. Teams will be scored and placed, first through tenth.

Directions: From Highway 79 at the Raymond Nebraska corner, take Raymond Road west for 6 miles. Turn right into Homestead Campground Area 2 and veer left to the equestrian campground.

Park Fees & Camping Facilities: Nebraska State Park Permit is required: \$31 annual or \$6 per day in state / \$46 annual or \$8 per day out-of-state and can be purchased online at <https://ngpc-home.ne.gov/>. This equestrian area offers 15 pull-through sites with electrical hookups reservable at the park office only, as well as 14 corrals. Call 402-783-3400 to reserve by the Thursday prior (no online reservations). The electric sites are \$25 per night; Horse pens are \$5 per day; Non-electric camping (basic) is \$15 per night per vehicle (at the time of this printing). Camping and park fees are NOT included in the entry fees. Please independently take care of all park fees. Hand-pump drinking water, toilets and fire rings are available in the equestrian camping area. **Dogs** are not allowed in management area, check-in and briefings or at meals and **must be leashed** at all times (insurance requirement).

Meals: Lunches are provided. A potluck dinner may be held Saturday night for those staying overnight and camping.

Join us for the competitive trail ride at Rock Creek Station Historical Park. Established in 1857 along the Oregon and California Trails, Rock Creek Station was a relay station for the Pony Express. Rich in cowboy history, you'll cross the bridge and ride through the ranch, through the creeks and prairies and canyons of Rock Creek Station and Rock Glen Wildlife Management Area. The terrain is mostly grassy meadows with some red rock in the canyon areas.

Directions: *Note: GPS will route you on minimum maintenance dirt roads. The following directions will keep you on blacktop.* **From Hwy 136:** Turn south in Jansen at the sign (573rd Ave). Drive south to 710 Road. Turn left (east) and go 1.25 miles. Turn in on your right. **From Fairbury:** Take 711 Rd/PWF 5 miles east. Turn right on 573rd Avenue & go 1 mile. Turn left (east) on 710 Rd and go 1.25 miles. Turn in on your right. **From Hwy 8:** Just east of Endicott, turn north on 573 Avenue for 3 miles. Turn right (east) on 710 Rd and go 1.25 miles. Turn in on your right.

Park Fees & Camping Facilities: Nebraska State Park Permit is required: \$31 annual or \$6 per day in state / \$46 annual or \$8 per day out-of-state and can be purchased online at <https://ngpc-home.ne.gov/>. Camping (basic) \$15 per night per vehicle (at the time of this printing) and can be paid at the kiosk in horse camp or at the Visitor's Center. Space is limited so management will assist with parking. The park now has a new restroom and shower house located between the horse camp and the south campground. **Dogs** are not allowed in management area, check-in and briefings or at meals and **must be leashed** at all times (insurance requirement).

Stabling: A-Ride: Horses will be stationary tied to horse trailers. Pens will be designated for working horses first (safety riders and trail markers), remaining pens can be used by B-riders and Leisure Division (first come first serve). Portable corrals are discouraged due to space limitations for trailer parking. Deposit manure in manure pile. Wheelbarrows are available. There are potable water hydrants throughout the horse camp.

Ride Details: All competing out-of-state horses must have negative Coggins and current Health. Terrain is barefoot friendly. No horses are allowed on wildlife management area unless working or competing.

A-Ride: Check-in starts at 2pm on Friday. **Leisure Division:** Check-in starts 9am on Saturday

B-Ride: Check-in starts 3pm on Saturday. Late check-ins should make arrangements with ride management.

Meals: Friday and Saturday evening are potluck with main dish provided by ride management. Please bring your own table service & drinks. All meals complimentary for ride workers.

Trails: Boundary and lake trails with woods and meadows. Little rock or hills. Trails are permanently maintained by Kearney Saddle Club volunteers.

Directions: Located between Smithville to the West (Hwy 169) and Kearney to the East (I-35) and Hwy 92 to the South. Drive west from Kearney or east from Smithville on 92 Hwy to “E” Hwy. Turn north on “E” and follows signs to Crow’s Creek Campground. At the stop sign in the park turn left and go to the campground. *The Jesse James homestead and museum are located nearby in Kearney, MO.*

Camping: Crows Creek Equestrian Campground, Loop A (sites 1-90) offers 50 amp electric and 50 amp electric/water camping sites for equestrians. Restrooms, showers, laundry, and water hydrants are conveniently located. **To register for a camping site call the park office at 816-407-3400. When you call be sure to identify yourself with the Jesse James Rideout.** The park is holding the entire campground for our use until May 1st. After that date they will only hold sites 1-27 and 64-90 for us until May 15th. After May 15th any sites not reserved will be available to the public as well on a first come first serve basis. Ice is available for purchase at the gate!

Stabling: Horses must be stationary tied.

Ride Notes: **Current Negative Coggins Certificate REQUIRED On All Horses. Current Health Papers (within 30 days of this event) REQUIRED On All Out-of-State Horses.** A ride briefing on Friday is planned for 6:00 p.m. No smoking on trails. Pets must be chained or leashed at all times. No dogs/pets in management areas, ride briefings, check-in, check-out, or where food is served.

Ride the beautiful forests in north-central Iowa.

Directions: From I-35 take exit 142B to the west Hwy 20 towards Ft. Dodge. Go approx. 23 miles. From Highway 20 take County Road P-73 (Union Ave) turn left (south). Go approx. 4 miles to 270th St. (Lakeview Drive), take a left (east) then take a left at the sign for the **North Equine Campground**.

Camping: Camping fees are \$14 for non-electric and \$19 for electric sites; additional fees for pre-registering at www.iowastateparks.reserveamerica.com, the Iowa DNR reservation system. Reservations may be made 3 months to 2 days prior to arrival. There are a number of sites that are on first come basis and cannot be reserved ahead of time. Facilities are a modern campground with modern restrooms and showers, dump stations, and playground. Dogs must be kept tied or on a leash at all times.

Stabling: All horses will be stationary tied to hitching posts.

Check-In: Check-in with ride secretary will begin at 1 PM. Check in of horses will begin at 2 PM until dusk on Friday. Ride briefing planned for 7 PM. B riders will check in Saturday afternoon at 4 PM.

Rules: Iowa law requires that all out-of-state horses have current Coggins and health papers. Health papers and Coggins will be checked at check-in. It is recommended that all horses have current vaccinations.

Meals: Potluck Friday and Saturday evening. Management will provide the meat. Please bring a dish to share. Please provide your own plates and utensils. Dogs are not allowed in management area.

Join us for our 46th annual competitive ride! This is a gorgeous ride through one of Nebraska's state parks boasting rich Native American and fur trade history as well as a stop along the famous Lewis & Clark route. You will ride well-marked and established trail over hills and bluffs along the Missouri River. The trails offer a variety of terrain from grassy meadows to challenging forested hills; a test of your skills and horses' condition.

Directions: From I-29 (northwestern Missouri), exit #110 (Hwy 136), go west on Hwy 136 one mile west of Brownville, NE. Turn left (south) on Hwy 67 and go approximately 9 miles to the sign that points to the park, turning left (east). **From Auburn, NE:** take Hwy 136 east to Hwy 67 and continue south to the Indian Cave State Park sign. **Note:** It is 14 miles to the park from the junction of Highways 136 and 67. Once in the park, stay on the main park road approximately 2.5 miles. Camp will be located directly west of the park's designated horse campground. Signs will be posted indicating camp location.

Camping: The Park will collect a camping fee, per night per vehicle, plus a day state park entry permit or you may purchase an annual Nebraska State Park sticker. Camping is primitive with outhouse facilities available. A shower house is available within a short drive to a neighboring campground. Water for horses is provided in camp. Dogs are not allowed in the management area, check-in area, at briefings, or meals and must be on a leash at all times. This will be strictly enforced per park regulations and our event insurance policy.

Stabling: Competing horses will be stationary tied to horse trailers. Due to space limitations, no corrals are allowed. Scatter manure into the woods.

Ride Details: Check-in for the A Ride will run from 2:00 – 6:00 PM on Friday or earlier if scheduling permits. Late check-ins must make arrangements with ride management. Check in for the Leisure Division ride will run from 9:00 – 10:00 AM Saturday morning. B Ride check in is tentatively scheduled for Saturday at 3:00 PM. **All competing out-of-state horses must have negative Coggins and a current Health Certificate.**

Meals: Friday and Saturday night potluck meals – bring a dish to share! The main dish will be provided by NECTRA both nights but please bring your own table service and drinks. All meals will be complimentary for ride workers!

NATRC Type A (Two-day) Ride: Open, Novice, CPOctober 26-27

Location: County Road 356, New Bloomfield, MO, approximately 15 miles southeast of Columbia, in the beautiful 15,000 acre Cedar Creek District of Mark Twain National Forest.

Trails: Scenic trails traverse woods and meadows, moderate hills, creek crossings, and a few gravel roads. Ride is suitable for first-time competitors, while the variety and beauty of the terrain will also interest experienced riders.

Directions: From the north, west and east: Take I-70 to Exit #137 (Millersburg exit). Take Hwy J south, go 3.3 miles, at "T" turn left, (staying on J), go 8/10 mile, turn right (staying on J). Go 7.4 miles to County Rd 356 (Paris Fork Church Rd), turn right. **Go 1 mile to campground on left.**

From the south: Take Hwy 54 north from Jefferson City. Go approximately 18 miles to the Fulton exit (marked Bus 54 and Hwy H). Take Hwy H west 6.5 miles. At "T" turn right on Hwy J. Go 1.1 miles to County Rd 356 (Paris Fork Church Rd), turn left. Go 1 mile to campground on left.

Camping: \$5 facilities fee per competitor; payable to Chris Wallis for Cedar Creek trail fund.

Management will park you as camping space is very limited. Campsite is primitive, with portable toilets and horse water provided at the site. No open fires. Bring your own drinking water and food for your horse.
